LAW APPLICABLE AND COURT OF LAW HAVING JURISDICTION

1. All agreements between the Storage Company and the Principal shall be governed by Dutch Law.

2. All differences that might arise between the Storage Company and the Principal and/or that are subject to these General Conditions shall have to be submitted by the Principal and can be submitted by the Storage Company for adjudication to the Court of Law having jurisdiction at the place where the storage space of the Storage Company is situated in the Netherlands. The Storage Company shall, however, be entitled to institute claims against the Principal or anyone else in another Court of Law having jurisdiction, in particular the Court of Law having jurisdiction at the place of establishment of the party against whom the Storage Company wishes to institute the claim in question.
