3. All parties finalize the signing of the NCNDA/IMFPA.
4. The Seller issues the POP documents as below and send to the Buyer.
  - a. Commitment to Supply
  - b. Certificate of Origin
  - c. Authorization to Verify (ATV)
  - d. Tank to Tank Injection Agreement (TTTIA)
  - e. Unconditional DTA
  - f. Fresh SGS (not older than 48 hours)
  - g. Tank Storage Receipt (TSR)
  - h. ATS – Authorization to Sell
  - i. Injection Report
5. The Buyer conducts Dip Test in the Seller's Tank and provide Tank Details to the Seller, to commence injection of product into the Buyer's Tank.
