5. Seller sends legalized contract and below Partial POP Documents to buyer as listed below:

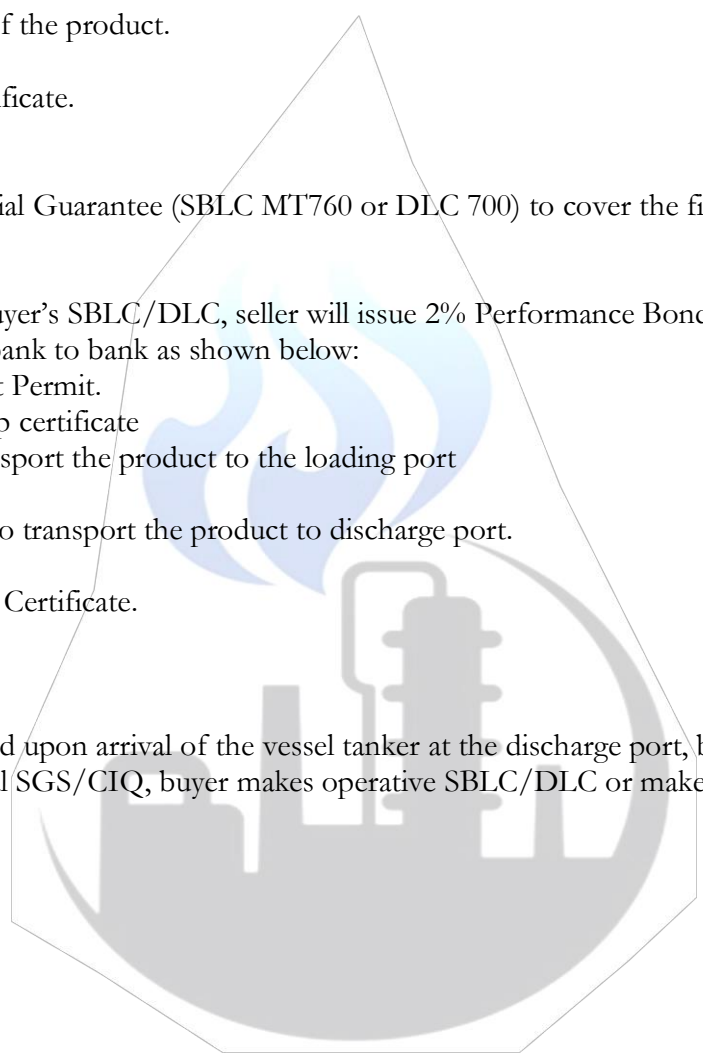
- Certificate of Origin.

6. Buyer issues their Financial Guarantee (SBLC MT760 or DLC 700) to cover the first shipment to seller's bank within 72hours (3days).

7. Upon confirmation of buyer's SBLC/DLC, seller will issue 2% Performance Bond, Full POP and Shipping Documents via SWIFT bank to bank as shown below:

- Port storage agreement.
- Charter party Agreement to transport the product to discharge port.
- Tank Storage Receipt.
- SGS Quality and Quantity Certificate.
