- 4. Seller releases POP cleared of Legalization and Notarization charges to buyer for verification.

- B. Marine Data Analysis Report.
- C. Certificate of origin GOST
- D. Company Registration Certificate.
- E. Product Quality Passport
- F. Statement of Product Availability
- G. Unconditional Dip test authorization letter

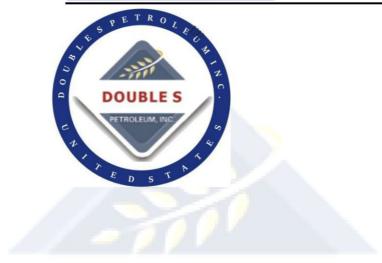
