## FOB TTV TRANSACTION PROCEDURE

2. Seller issues Commercial Invoice (CI) buyer signs and returns the signed invoice to the seller.
3. Seller issues to the buyer the partial proof of product documents  
ATSC Authority to sell and collect  
DTA - Dip Test Authorization  
PRODUCT PASSPORT - Product analysis report from a renowned inspection company.  
STATEMENT OF PRODUCT AVAILABILITY  
COMMITMENT LETTER TO SUPPLY  
ATV - Authority to verify the existence of product via email or phone call.
4. Buyer extends seller's tank (minimum 2 days) and receives full GPS coordinates of the tanks , Hub access permit and dip test is conducted immediately with buyer's team to obtain fresh SGS report
5. After a successful Dip Test in Seller's tanks, Buyer takes over seller's tank or Seller injects into buyer's tank, buyer conducts its DIP TEST Inspection for Q & Q of the Petroleum Products aboard vessel / Tank. va
6. Buyer after a successful Q & Q Dip test on the product, the buyer makes the payment for the total price into the tanks through the means of MTI03 - TT or USDT. Best regard
8. Upon seller receives the payment for the product from the buyer, the seller issues to the buyer the bill of lading for the product and all exporting documents of the Product. The seller pays all intermediaries involved in the transaction.
