### **1. OBJECT OF AGREEMENT. GENERAL CONSIDERATIONS**

1.1. According to the present agreement the keeper is responsible to store the goods, transmitted to it by owner, and to return these goods in the safety.

1.2. The object of present agreement is storage of JET FUEL A-1 that named subsequently goods.

1.3. Keeper is responsible to accept goods to the storage within the following period \_\_\_\_\_

Owner, who did not transmit goods to the storage in time, provided by the subparagraph of 1.3 present agreements, bears responsibility before the keeper for the losses, caused in connection with the cancelled storage, if another is not provided by law. Owner is freed from this responsibility, if he states to keeper about the failure of his services within a reasonable period of time. (Ok this pushes the responsibility to the owner of the goods and the keeper is freed from responsibility if the owner does not perform)

1.5. Keeper is freed from the responsibility to accept goods to the storage in the case when within the caused by present agreement period goods will not be to it transmitted.
