1. Seller's official representative issue's soft offer and buyer sends ICPO, CP and tank storage agreement (TSA) as proof of storage tank availability.
2. Seller Verifies and Issues: Commercial Invoice / (CI),
 - A. Commitment to Supply.
 - B. Statement of Product Availability. Buyer Signs and Returns CI to seller.
3. Seller leases and pays the buyer's tank for 3 days first and Buyer does pay his Tank Farm Company for 2 days after his Tank Farm Company has received the payment from Seller Company.
4. Seller issues following POP documents to Buyer:
 - GPS Coordinate-Tank storage receipt (TSR)
 - Injection report
 - Certificate Of Origin
 - Product passport
 - Dip test authorization letter (DTA) – Unconditional
 - Authorization to Sell and To Collect (ATSC)
 - Fresh SGS Report
 - Authorization to Physically to Verify (ATV)
5. Buyer conducts Dip test on the product and makes the payment for the total value of product injected into the tanks through the means of MT103- TT.
6. Seller pays both sides Mandates in the transaction and subsequently monthly shipment continues as per terms and conditions of the sales and purchase agreement contract between buyer and seller.
