3. Upon signing of the M.O.U, seller issues to the following documents;
 - A. Certificate of origin of Product
 - B. Reversed Bill of Lading
 - C. Vessel details
 - D. Cargo manifest
 - E. Ullage Report
 - F. Product Passport (Quantity & Quality analytical report)
 - G. Invoice for title transfer payment.

4. For proof of product the sellers make arrangements with the vessel company and they schedule a video call with the buyer and seller in the vessel to show the buyer vessel.

5. Buyer pays for the Title Transfer of the product into their company name to get the certificate of ownership of cargo as needed before the vessel can enter the destination port of the buyer. Total cost for title transfer USD210,000.00 via TT Wire Transfer.

6. Upon confirmation of payment, seller instructs the vessel captain to anchor the vessel to buyer's destination port and change the Title to the buyer company name and issues all new ownership documents in buyer company name inclusive of the revised Bill of Lading (importer/consignee) within 24 hours.

7. Upon arrival of the product at buyer's destination port, buyer conducts CIQ on the product and releases the remaining balance of the cargo via MT103 after satisfaction of CIQ result.
