  - Certificate of Origin of the Product.
- 3.** Seller logistics team verify buyer's provided tank farm and pay 3 days first on buyers Tank farm and after confirmation of the funds by buyer's tank farm, Buyer pays the Remaining 2 days to his Tank Farm Company to obtain 5 days TSR, to show both Parties proof of readiness. GPS Coordinate-Tank storage receipt (TSR)
- 4.** Seller issues following POP documents to Buyer:
  - a) Injection report.
  - b) Dip test authorization letter (DTA) – Unconditional.
  - c) Authorization to sell.
  - d) Fresh SGS Report or equivalent.
  - e) Authorization to verify the product in seller's tank (ATV)
- 5.** Buyer conducts Dip test on the product and makes the payment for the total value of product injected into the tanks through the means of MT103- TT.
- 6.** Product Injection to buyer's tank proceed.
