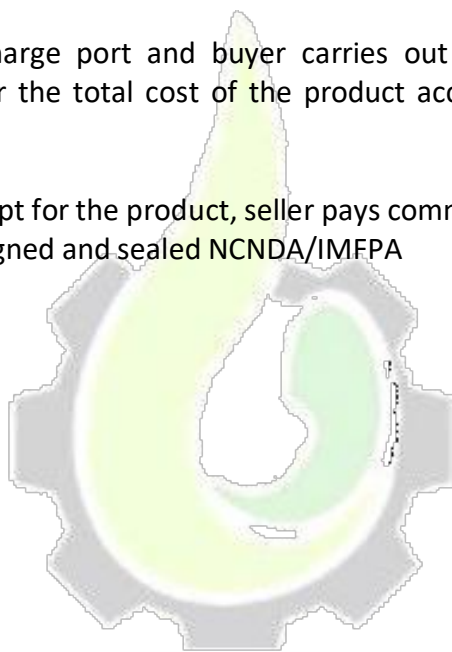

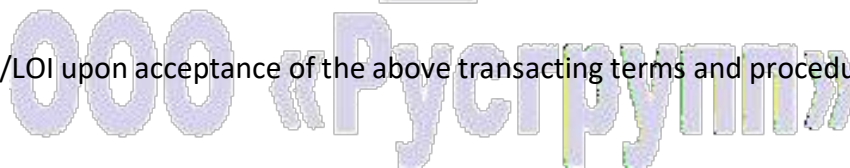
8. Seller issues NCNDA/IMFPA to be sign by all intermediaries involve in the transaction.
