- 2. Seller issue commercial invoice to the buyer, buyer sign and return commercial invoice to the seller
- 3. Seller send a copy of SGS Report to buyer's tank farm for verification of the SGS Report only by buyer's tank farm to receive and confirm SGS report to Buyer.
- 4. Upon confirmation and successful verification of the SGS report by buyer's tank farm company, seller leases and pays the buyer's tank for 3 days. After buyer tank farm receives payment for tank lease from the seller for 3 days, buyer leases and pays for his tank farm for another 3 days.
- 5. Seller issues the below full POP documents to buyer:
- A. Product Passport
- B. Q&Q report
- C. Unconditional DTA
- D. ATV
- E. ATSC
- F. Valid TSR
- G. Injection Report
- H. Certificate of Origin
- 6. Buyer conducts dip test inspection on the product in seller tanks (OPTIONAL)
- 7. Seller transfer product to buyer's tank. Buyer conduct dip test of the product in buyer's tank. Buyer pays for the total product
- 9. Seller immediately transfer the title of product ownership to buyer with all export documents
