1. Buyer issues ICPO along with Company profile, copy passport and company register copy. Seller verifies Buyer's ICPO with Company profile and company register copy.
2. Seller issue the contract sign between Buyer and Seller and after contract final signed both Buyer and Seller submit the contract to their respective bank.



Buyer conduct the Dip Test in seller tank till (Seller can't give more than 5 (five) working days without payment any tank Farm), after Buyer paid for TCS and then Seller perform in pumping the fuel in Buyer tank or vessels. Then the Seller will send NCNDA/IMFPA to intermediate completed and signed send back to the Seller.

4. Seller issues Full Set of Proof of Product Original copy in Buyer name Confirm and seal by ICC Chamber and Seller Bank and Fresh SGS.

5. Upon successful Dip Test and Buyer is product in their tank or vessel, then Buyer makes payment Via MT103 for the total amount of the product after minus the cost rendered by Buyer Tank Cleaning Services (TCS) and balance payment must be done by Express via TT/MT103 within 48 hours and submit the bank payment confirmation slip transfer to our authorize department. Seller paid intermediaries involved in NCND/IMFPA within 24 hours and maximum 72 hours.

6. If Buyer Failed to make the payment of the Goods after the product in the Buyer's Tank, Seller will immediately report the Buyer to INTERPOL, will drag such a buyer to the court of law and penalty of 1% of the total cost product will pay by Buyer to the Seller after the Buyer paid for the full cost of the product. If Seller also failed to deliver according to the contract, Buyer have the right to report the Seller to INTERPOL or any related criminal agency and Seller also will pay the penalty 1% to Buyer.
