- 2. Upon seller's approval of ICPO/BUYERS Details and TSA, Seller issue Commercial invoice to Buyer company and Buyer signs and returns signed «COMMERCIAL INVOICE».
- 3. Seller Legalese's and Registers the signed «COMMERCIAL INVOICE» at the appropriate Ministry incharge (on sellers' expense) and issue to the Buyer the Partial Proof of Product (PPOP) Documents:
- A. Legalized and Notarized Commercial Invoice
- B. Product Passport (Quality and Quantity Analytical Report)
- C. Authority to Sell and Collect (ATSC)
- D. Statement of Product Availability.
- 4. Upon proper verifications of the above documents, Buyer provides Notice of Readiness (NOR) From their Tank Storage Company confirming that buyer's storage tank company is ready to receive the products after Dip Test on seller's tank.
- 5. Upon receipt of Buyer's NOR, seller issues to buyer the Full Poof of Product (POP) document.
